- b. Accordingly, in terms of Regulation 14(1) of the SEBI ICDR Regulations, there is no requirement of minimum promoter's contribution in the Offer and accordingly, no Equity Shares will be locked in for a period of 18 months from the date of allotment of Equity Shares pursuant to the Offer.

B. Exemption application under Regulation 300(1)(a) of the SEBI ICDR Regulations

The Company has filed an exemption application dated March 4, 2024, with SEBI under Regulation 300(1)(a) of the SEBI ICDR Regulations, seeking an exemption from the lock-in under Regulation 17 of the SEBI ICDR Regulations of the Equity Shares allotted to certain employees and former employees of the Company pursuant to exercise of employee stock options under the ESOP Schemes of the Company, and were contributed to a trust settled by the Company, namely, the Swiggy Liquidity Trust. The Company has further submitted a response dated April 8, 2024 to the clarifications received from the SEBI on March 6, 2024. A response or an exemption from SEBI is currently awaited.

C. Application to Stock Exchanges and Designated Stock Exchange

The Company has undertaken to apply to the BSE Limited and the National Stock Exchange of India Limited for obtaining in-principle listing approval for listing of the Equity Shares. In compliance with and pursuant to the SEBI ICDR Regulations, the Company shall appoint the 'Designated Stock Exchange' prior to the filing of the Red Herring Prospectus with the RoC.

D. Unified Payments Interface ("UPI")

The timeline of T+3 days for the UPI Mechanism for applications by UPI Bidders ("UPI Phase III"), and modalities of the implementation of UPI Phase III has been notified by SEBI vide its circular no. SEBI/HO/CFD/TPD1/CIR/P/2023/140 dated August 9, 2023 and made effective on a mandatory basis for all issues opening on or after December 1, 2023. Accordingly, the Offer will be undertaken pursuant to the processes and procedures under UPI Phase III, subject to any circulars, clarification or notification issued by the SEBI from time to time.

Note explaining how the process of due diligence has been conducted

The Legal Counsel assisted the Book Running Lead Managers in carrying out legal due diligence, drafting of the Pre-filed DRHP in compliance with the SEBI ICDR Regulations and other applicable laws and advising the Company and the Book Running Lead Managers on other relevant legal matters related to the Offer, in their respective roles.

The Book Running Lead Managers were also assisted by the current statutory auditors of the Company, B S R & Co. LLP, Chartered Accountants, a peer reviewed chartered accountant firm (the "Statutory Auditors"), in the due diligence process, and have provided an examination report dated April 19, 2024 (the "Examination Report") in relation to the restated consolidated financial information of the Company and its Subsidiaries and its associates ("Restated Consolidated Financial Information"). Independent Chartered Accountant has also confirmed to us that all related party transactions for the periods for which the Restated Consolidated Financial Information is disclosed in the Pre-filed DRHP have been entered into in accordance with applicable laws, on an arm's length basis. The Independent Chartered Accountant has also consented to be named as an expert, in terms of the Companies Act, 2013, in the Pre-filed DRHP. Further, the independent architect, Architects IN, ("the Independent Architect") has certified the quotations obtained by the Material Subsidiary for the purchase of components, fit-outs and installations of the Dark Stores in relation to the Company's Objects towards expansion of the Dark Store network for its Quick Commerce segment through setting up of Dark Stores. The Independent Architect has also consented to be named as an expert, in terms of the Companies Act, 2013.

The Company has also placed reliance on the report titled "Report on Indian Hyperlocal Commerce Opportunity" dated April 24, 2024 by the Industry Report Service Provider, Redseer Strategy Consultants Private Limited ("**Redseer**" and such report, the "**Redseer Report**"), for disclosures relating to the industry information in the Pre-filed DRHP. Further, the Company has received a written consent dated April 24, 2024 from Redseer to include contents of the Redseer Report in the Pre-filed DRHP and other Offer related documents.

The due diligence process carried out by us and the Legal Counsel involved attending a virtual kick-off meeting and interactions with the senior management of the Company for gaining an understanding of the business of the Company and its Subsidiaries, key risks involved and financial overview of the Company, among other matters.

Further, we have also visited certain premises of the Company and its Material Subsidiary including the registered and corporate office, certain dark store and warehouse where the business operations are carried out. We also provided the Company with a due diligence questionnaire and information request list prepared in consultation with the Legal Counsel. The Company provided us the supporting documents in relation to the questionnaire for our review and diligence and provided us with explanations with respect to our queries. In order to facilitate such review, the Company set up a virtual data room where copies of such supporting documents were made available for undertaking such due diligence.

1. Business and commercial diligence

The due diligence process in relation to general business and commercial matters included:

(a) Organizing and attending transaction related calls and virtual meetings with the management of the Company to develop an understanding of the business, history and other matters of the Company and its Subsidiaries, including the industry overview and the regulatory environment. The discussions were attended by the Managing Director and Group Chief Executive Officer, Chief Financial Officer, Company Secretary and Compliance Officer and the senior management of the Company, along with other members of the secretarial, legal and finance departments of the Company, the Book Running Lead Managers, Legal Counsel and the Statutory Auditors. A broad overview of the business of the Company, industry in which it

operates, regulatory framework with respect to its business, history of the Company, corporate structure, financial statements, as well as their capital structure, and shareholding pattern were presented to us and the Legal Counsels, followed by interactive discussions.

- (b) Requesting the Company to provide relevant documents in the data room based on the diligence requirements and requirements under applicable law, including the SEBI ICDR Regulations, and reviewing such documents along with the Legal Counsel, as is customary in such a transaction.
- (c) Regularly interacting with the management team of the Company, including the Company's Key Managerial Personnel, Senior Management Personnel from the Company's secretarial, legal and finance departments and the Statutory Auditors for the purpose of gaining an understanding of the business, the risks involved and a financial overview of the Company, among other matters. These interactions included (i) due diligence calls to discuss the disclosures in the Pre-filed DRHP; (ii) due diligence calls with the Statutory Auditors and the Independent Chartered Accountant; (iii) bring-down due diligence calls to receive updated information from the Company before filing the Pre-filed DRHP; (iv) seeking appropriate certification from the Statutory Auditors and the Independent Chartered Accountant; (v) seeking appropriate certification from the Company, its Subsidiaries, its Group Companies, its Directors, the Key Managerial Personnel, and the Senior Management Personnel; and (vi) due diligence calls with certain restaurant partners, brand partners, merchant partners and vendors of the Company and/or its Subsidiaries. These interactions were conducted with the objective of assisting the Company with preparing the disclosures in the Pre-filed DRHP, as required under the SEBI ICDR Regulations and other applicable laws with regard to the Offer. The Book Running Lead Managers shall undertake these interactions and due diligence calls until the allotment of Equity Shares in the Offer, as necessary. Accordingly, based on such interactions and the documents made available, disclosures in respect of the business carried out by the Company as well as associated risks in relation thereto, have been made in the sections titled "Our Business" and "Risk Factors", respectively, in the Pre-filed DRHP.
- (d) Further, the Book Running Lead Managers and the Company also interacted with the representatives of the Selling Shareholders, on the disclosures in the Pre-filed DRHP in relation to each Selling Shareholder and the Equity Shares being offered by them in the Offer for Sale. These interactions were conducted with the objective of assisting the Company to prepare disclosures as required under the SEBI ICDR Regulations and other applicable laws in connection with the Offer. The Book Running Lead Managers shall undertake these interactions until the allotment of Equity Shares in the Offer, as necessary.
- (e) Obtaining circle-ups from the current statutory auditor, previous statutory auditors and the Independent Chartered Accountant on financial information as well as certifications for the operational data and certain financial related information included in the Pre-filed DRHP, as on and for the periods specified therein.

The Book Running Lead Managers have obtained and relied on certification from the Independent Chartered Accountant for certain key performance and operational data of the Company and in relation to certain financial related information.

3. Industry information

We have relied on industry and market data derived from the Redseer Report included in the section titled "Summary of the Offer Document", "Risk Factors", "Industry Overview", "Our Business" and "Management's Discussion and Analysis of Financial Condition and Results of Operations" in the Pre-filed DRHP.

The Redseer Report has been exclusively commissioned and paid for by the Company, for the purposes of confirming its understanding of the industry, in connection with the Offer. We have also interacted with Redseer and conducted calls with them to discuss the contents of the Redseer Report. The industry related information contained in certain sections of the Pre-filed DRHP, including "Summary of the Offer Document", "Risk Factors", "Industry Overview", "Our Business" and "Management's Discussion and Analysis of Financial Condition and Results of Operations", has been included from the Redseer Report. The Redseer Report will be made available on the website of the Company on and from the date of filing of the Red Herring Prospectus and has been included as one of the documents that will be available to the public as a material document for inspection.

4. Financial information

The Pre-filed DRHP includes the Restated Consolidated Financial Information of the Company, and its Subsidiaries and its associates comprising of the restated consolidated statement of assets and liabilities as at December 31, 2023, March 31, 2023, March 31, 2022 and March 31, 2021 and the restated consolidated statement of profit and loss (including other comprehensive income), the restated consolidated statement of changes in equity and the restated consolidated statement of cash flows for the nine months period ended December 31, 2023, year ended March 31, 2023, March 31, 2022 and March 31, 2021, material accounting policies, notes to the restated consolidated financial information and statement of restated adjustments to the audited consolidated financial statements as at and for the nine months period ended December 31, 2023, year ended March 31, 2023, March 31, 2022 and March 31, 2021, prepared under Ind AS notified under Section 133 of the Companies Act, 2013, and in accordance with requirements of Section 26 of Part I of Chapter III of the Companies Act, Paragraph (A) of Clause 11 (I) of Part A of Schedule VI of the SEBI ICDR Regulations and the Guidance Note on Reports in Company Prospectuses (Revised 2019) issued by the Institute of Chartered Accountants of India as amended from time to time.

The Book Running Lead Managers have reviewed the Statutory Auditors' reports and obtained certification with respect to utilization of the loans for the purposes for which they were availed by the Subsidiaries of the Company (pursuant to the requirements of paragraph (A)(2)(b) of Clause (9) of Part A of Schedule VI of the SEBI ICDR Regulations). The Book Running Lead Managers had extensive discussions with the Statutory Auditors on the form and manner of the reports required for such financial information. Further, the Statutory Auditors were required to review the consolidated financial information relating to the Company in the Pre-filed DRHP and have delivered their examination report on the restated consolidated financial information and a customary comfort letter to the Book Running Lead Managers confirming the accuracy of the financial information contained in the Pre-filed DRHP. The Independent Chartered Accountant has also verified and provided certifications in respect of certain other operating information included in the Pre-filed DRHP. Such comfort letter and certificates will be re-issued or brought down at certain future dates as the Offer moves forward.

In addition to the above, as part of our diligence, we have had discussions with the management of the Company and the Statutory Auditors and have relied on explanations and representations provided to us by the management of the Company that all the related party transactions entered into for the periods disclosed in the Pre-filed DRHP have been entered into by the Company in accordance with applicable laws. We have also obtained a certificate from the Independent Chartered Accountant certifying compliance of the related party transactions entered into by the Company with relevant accounting standards and applicable law.

The Company will upload its standalone audited financial statements for the three financial years immediately preceding the date of filing of the Updated Draft Red Herring Prospectus-I ("UDRHP-I") on its website at the time of filing the UDRHP-I with the SEBI. In addition, the standalone audited financial statements of the Material Subsidiary, in accordance with the SEBI ICDR Regulations, for the three financial years immediately preceding the date of filing of the UDRHP-I will also be available on the Company's website at the time of filing the UDRHP-I with the SEBI.

The Book Running Lead Managers have relied on the certificates provided by the Independent Chartered Accountant, in relation to, *inter alia*, the computation of the Company's net worth, operating profit/loss and net tangible assets, each based on the Restated Consolidated Financial Information for Fiscals 2023, 2022 and 2021, to assess the eligibility of the Company to undertake the Offer under Regulation 6(2) of the SEBI ICDR Regulations.

The Book Running Lead Managers have relied on the certificates provided by the Independent Chartered Accountant to ascertain the amount of outstanding borrowings of the Company on a consolidated basis as of February 29, 2024, as disclosed in the sections titled "Financial Indebtedness" and "Management's Discussion and Analysis of Financial Condition and Results of Operations—Indebtedness" of the Pre-filed DRHP. While there are no consent requirements from relevant lenders to undertake the Offer and related corporate actions such as issue and allotment of the Equity Shares and change in the capital structure of the Company, among other things, the Company has intimated the lenders of such actions.

5. Objects of the Offer

The Company proposes to utilise the Net Proceeds for the following purposes: (i) investment in its Material Subsidiary, Scootsy, for repayment or pre-payment, in full or in part, of certain or all of its borrowings; (ii) investment in its Material Subsidiary, Scootsy, for (a) expansion of the Dark Store network for the Quick Commerce segment through setting up of Dark Stores; and (b) making lease / license payments for Dark Stores; (iii) investment in technology and cloud infrastructure; (iv) advertising expenses to acquire and retain users by enhancing the brand awareness and visibility of the Company's platform, across its segments; and (v) funding inorganic growth through unidentified acquisitions and general corporate purposes (collectively, the "Objects").

In relation to the loans which are proposed to be repaid or pre-paid, the Statutory Auditors have provided a certificate confirming that such loans were utilized for the purposes for which they were availed. We have also reviewed the terms and conditions of the financing facilities and assessed the requirement to obtain consent, waiver, no-objection or intimation in respect of the lenders.

In relation to the Object towards investment in the Material Subsidiary, Scootsy, (a) expansion of the Dark Store network for the Quick Commerce segment through setting up of Dark Stores; and (b) making lease / license payments for Dark Stores, we have, *inter alia*, reviewed, on sample basis, the material approvals required for Dark Stores. the lease / leave and license agreements for Scootsy, agreements entered into by Scootsy and the Company vis-à-vis merchant partners, reviewed the valid quotations obtained by Scootsy, from various contractors/vendors for purchase of components, fitouts and installations required for setting up Dark Stores which have also been certified by the Independent Architect.

In relation to the Object towards investment in technology and cloud infrastructure, we have reviewed, on sample basis, the technology agreements entered into by the Company for cloud storage and infrastructure services, data management, processing and analytics services and digital map platform services with various third party cloud architecture vendors.
